The **Autumn School** is an **international intensive course held online** that offers the possibility of an academic and professional training on the subject of International Human Rights Law (IHRL), International Humanitarian Law (IHL) and International Criminal Law (ICL) with regard to the Protection of Children in Armed Conflict and with a specific focus on gender issues.

THE AIM OF THE AUTUMN SCHOOL

This intensive course is open to all those interested in learning more about the protection of children affected by armed conflict and in analyzing the judicial and social aspects of violence against them.

The course will cover key issues related to the protection of these children, in particular girls, offering the participants a comprehensive knowledge of the topic with a particular focus on not only a theoretical perspective but also a practical one.

The classes will involve the participation of attendees from different fields of study and training.

The course also aims to ensure a space for networking among the trainees in order to further explore aspects covered during the lessons and to create like-minded *Children and Armed Conflict (CAAC)* and *United Nations Security Council Resolution (UNSCR) 1325* “champions groups” coordinated by the professors of the course.

PARTICIPANTS

It is required that the participants have a background in Law, Political Science, International Relations or Sociology. It is preferable that participants hold a University degree (at least a BA or equivalent with 3 years of studies in these disciplines) or have an equivalent professional experience in a relevant field.

Having already completed a three-year course is a non-mandatory requirement.

Graduates of other disciplines will be considered depending upon the courses they have followed.

We particularly encourage the participation of those from the universities and research centers that are part of the Universities Network for Children in Armed Conflict as well as organizations working in the sector.

SCHEDULE

The **Autumn School** will be held online **from 16th October 2023 to 3rd November 2023** (for the schedule refer to the *programme* you can find below).

The attendance of participants from different countries is foreseen. For this reason the difference in time zones will be considered and **the course will be held from 2:30 pm to 5:30 pm CET (Central European Time)** so to allow every participant from different geographical areas to attend it.

The online course will be recorded and made available to enrolled people for consultation in the days following the school.

The course will be held in English.

COURSE ORGANIZATION AND CONTENTS

The Autumn School favours a balance between theory and practice. The theme of the protection of boys and girls in armed conflict will be analyzed through multidisciplinary approach and with a specific insight into the actions undertaken by States in line with the provisions of the United Nations Security Council Resolution (UNSCR) 1325 “Women, Peace and Security”.

The speakers will be selected from international and regional organizations, institutions and agencies, NGOs, and will include professors and experts in different fields who are collaborating in the project activity of the Universities Network.

During the *first week* of the course, the participants will receive an overview of international and regional legal and social framework for protecting children in armed conflict from speakers bringing their experience and expertise to the discussion. A round table that will take place on the last day of the first week will be specifically dedicated to the *gender perspective* in relation to the UNSCR 1325.

During the *second week* of the course, the situation in different geographical contexts, the national action plans and case studies in different countries will be analysed with the aim of contextualizing the general topic of the course with insights from the field. A round table that will take place on the last day of this second week will be dedicated to the topical issue of the International Justice for combating crimes against children affected by armed conflict.

A final individual examination of the course is foreseen. It will consist of an **essay of a maximum of 10 pages** on a specific topic covered during the course.

The last days of the course will be dedicated to the preparation of this final individual examination with in-depth sessions on *Children and Armed Conflict (CAAC)* and *United Nations Security Council Resolution (UNSCR) 1325* issues with the support of professors and experts from the Universities Network.

The individual essay must be sent not later than 5 days after the end of the course.

The certificate will be issued at the end of the course after receiving the final individual essay and with a minimum attendance of 70% of the entire course.

LECTURERS' BIOS

Ms. Dato' Shyamala ALAGENDRA, *International Criminal Lawyer (Malaysia) / International Criminal Court Bar Association*

Dato' Shyamala Alagendra is a Malaysian lawyer with over 24 years domestic and international criminal law experience. She has served as a Prosecution Trial Lawyer at the International Criminal Court (ICC), Special Court for Sierra Leone and before the Special Panel for Serious Crimes in East Timor. At the SCSL, she prosecuted cases where child soldiering crimes were charged for the first time by an internationalised court. During her time as the Assistant Director of Public Prosecutions of Fiji between 2018-2019, she led prosecutions of child rape cases and secured the first life sentence for child rape ever to be imposed in Fiji and the Pacific. She has represented victims of human rights violations (including killings, torture and sexual violence) by regional peacekeeping troops, including victims who were children at the time of the violations. She serves as a Gender & Child Rights Adviser in the UN. She has also represented accused persons as Counsel domestically in Malaysia and internationally at the ICC, STL and at EULEX Court in Kosovo.

Mr. Ahmed Aubais AL-FATLAWI, *Professor at the University of Kufa (Iraq) / Member of the Scientific Committee of the Universities Network research activity on Asia*

Ahmed Aubais Al-Fatlawi is a specialist in international criminal law and holds PhD in law from the Higher Institute at the Lebanese University 2012 also holds a diploma in IHL from the Geneva Academy for IHL and human rights in 2017. He is a full professor at the Faculty of Law/University of Kufa. Prof. Al Fatlawi has been engaged in several international academic forums as his participation in the advanced seminar studies in IHL, launched by the ICRC in 2017. Prof. Al-Fatlawi participated with experts from prestigious academies worldwide in updating guidelines for protecting the natural environment in times of armed conflicts. Published by the ICRC in 2020. He also participated with several international experts in updating and re-commenting on the Third Geneva Convention, published by Cambridge University Press 2021. Author of more than ten books on international criminal law and international humanitarian law, as well as preparing legal studies in cooperation with the Universities Network for the Protection of Children in Armed Conflicts. He currently supervises several dissertations, theses in level doctoral and master's students in public international law. Finally, he is now a member of the scientific committee in the national committee of IHL, Prime Minister Office of Iraq.

Ms. Klodiana BESHKU, *Professor at the University of Tirana (Albania)*

Klodiana Beshku is Associate Professor at the Department of Political Sciences, Faculty of Social Sciences of the University of Tirana. She has conducted a post-doc as a Jean Monnet Fellow at the Robert Schuman Centre of Advanced Studies of the European University Institute during 2020-2021. She has received a PhD in Geopolitics from the University of Pisa and a M.A. Degree in European

Studies from the University of Siena, Italy and the University Robert Schuman III of Strasbourg, France. She has held visiting research position at the School of Transnational Governance of the European University Institute. As a lecturer and visiting professor, she has taught academic and policy-oriented audiences in places such as University of Florence, University of Catania, University of Palermo, University Aleksandër Moisiu of Durrës, Albanian-American Development Foundation, Institute for Women in National and International Policies in Tirana, Institute for Philosophy and Social theory in Belgrade and the Centre of Excellence of the Ministry for Europe and Foreign Affairs of Albania. She has also held advisory positions for the Ministry for Europe and Foreign Affairs of Albania on European Integration and the Western Balkans. Her research centres on European Integration and Enlargement, Geopolitics of the Western Balkans and Social Movements. Her first book as a co-editor *Albania and Europe in a Political Regard* appeared with Cambridge University Press (2013). Other research has appeared or is forthcoming in *Journal of Southeast European and Black Sea Studies*, *Studia Politica* and *Journal of Liberty and International Affairs*.

Mr. Aristide CANEPA, *Professor at the University of Genoa (Italy) / Member of the Scientific Committee of the Universities Network research activity on Asia*

Aristide Canepa, PhD in constitutional law at the University of Bologna, is Associate Professor of Constitutional Law at the Department of Political and International Sciences of the University of Genoa and coordinator of the three-year degree course in Administrative and Political Sciences. He was also coordinator of the undergraduate program in International and Diplomatic Sciences, coordinator of the PhD in Democracy and Human Rights (Genoa) and Director of the Department of European Research. Within the framework of several cooperation programs, has carried out educational and organizational missions at numerous European and South American universities, as well as participated in dissemination and support for the constituent process in some Middle Eastern countries. He was co-director of the review “Gli Stranieri. Rassegna di Studi e Giurisprudenza”. He is part of the International Advisory Board of “Zbornik radova Pravnog fakulteta u Splitu/Proceedings of the Faculty of Law in Split” and of the editorial board of “Diritto Pubblico Comparato ed Europeo” and is a referee for other scientific reviews and editorial series. He is a member of the Executive Board of UNETCHAC. His research interests have always focused on comparative constitutional law.

Mr. Greg CARROLL, *Professor at the Salem State University (USA)*

Greg Carroll Ph.D., is a Professor of Peace and Conflict Studies at the Center for Human Rights and Human Rights Education at Salem State University in Massachusetts, USA, and a Fulbright Specialist. His research interests include human rights, youth nation-building in divided societies, resilience and globalization. He has worked extensively in the West African country of Liberia and the Southeast Asian nation of Timor-Leste, since 2015 he has been collaborating with Petro Mohyla Black Sea National University, a Ukrainian national university in Mykolaiv. Mr. Giuseppe CATALDI, *Professor at the University of Naples “L’Orientale” (Italy) / Member of the Scientific Committee of the Universities Network research activity on Europe*

Giuseppe Cataldi is full Professor of International Law and Director of the Department of Social and Human Sciences in the University of Napoli “L’Orientale” (University Vice-President, 2008-2014). Coordinator of the European Network Jean Monnet “MAPS” (Migration and Asylum Policy Systems. Weaknesses, Shortcomings and Reform Proposals). He is the President of the International Association for the Law of the Sea (AssIDMer), author and editor of many articles and books on International Law and European Union Law issues, in particular concerning Law of the Sea, Human Rights, Migration, Relationship among domestic and international order. EMUNI (Euro-Mediterranean University) Management Board Member (former Senate Member). Visiting Professor in the Universities of Faro (Portugal), Cordoba (Spain), Kobe (Japan), Alexandria (Egypt), Paris 1 Sorbonne and Paris 2 Sorbonne-Assas (France) Shanghai, Xiamen and Beijing (China), Quito (Ecuador). From 2000 to 2015 he directed the “International Institute for Juridical Studies”, CNR (Italian National Research Council). He has worked as Consultant for many International as well as National Institutions (also Italian Parliament, 2019 on Migration issues) and private firms, pleading beyond numerous international courts. Former member of the Expert Group on "Mediterranean Governance" appointed by the IUCN (International Union for the Conservation of Nature). Member of the Italian delegation to the 21st session of the UNESCO World Heritage Committee (1997). He was legal advisor to the European Union Commission - Directorate General for Fisheries, on the legal issues of fisheries management in the Mediterranean, and in this capacity member of the official delegation of the European Commission to the Diplomatic Conference in Crete (December 1994). Cofounder and co-director of “Diritti umani e diritto internazionale”, co-director of “The Italian Yearbook of International Law”. Member of the Italian Society of International Law (Vice-President, 2012 - 2013) and of the Société française de droit international.

Mr. Sanar Taha DARWISH, *National Legal Advisor ICRC Baghdad (Iraq)*

In 2015, Sanar Taha Darwish obtained a bachelor’s degree in public law from Salahaddin University/ Erbil- Kurdistan Region of Iraq. As a bachelor's student, he worked pro bono for the Legal Clinic in the same faculty between 2012 -2015. He interned in the program on Access to Justice under the auspice of USAID in 2014. He was also a Program Adviser for the European Union-funded project Support to Higher Legal Education in Iraq in 2015.

In 2015, he became a registered member of the Iraqi Bar Association. In 2016, he obtained a Master of Laws (LL.M.) in International Criminal Justice from the United Nations Interregional Crime and Justice Research Institute (UNICRI) and the University of Turin – Italy.

Since 2017, he has been working as a Legal Adviser in the ICRC/ Iraq Delegation. Within the assigned working duties, he gives sessions on IHL for undergraduate and postgraduate law students in Iraqi universities on thematic and general topics related mainly to this field of law.

He participated in the Philip C. Jessup International Law Moot Court Competition/ Iraq National Rounds 2014 during his bachelor studies. He was awarded the Best Oralist prize in the International Criminal Law Moot Court Competition as part of the LL.M. program and obtained the highest mark with distinction. He also participated in the first edition of the advanced training course 2022 on “International Criminal Jurisdiction Involving Children in Armed Conflict”. I was awarded the first-ranked participant in this international course.

Additionally, under the auspices of the Centre for International Law Research and Policy (CILRAP), with a group of Arab experts, we were requested to voluntarily participate in the edition of the Arabic translation of the Commentary on the Rome Statute by Professors Klamberg and Bergsmo, which is available and accessible for free use on Lexis website.

Mr. Stefano DOMINELLI, *Professor at the University of Genoa (Italy)*

Stefano Dominelli holds a Phd in international law from the University of Genoa, where he currently is Senior researcher and Assistant professor, teaching International law and International Law of Armed Conflicts.
